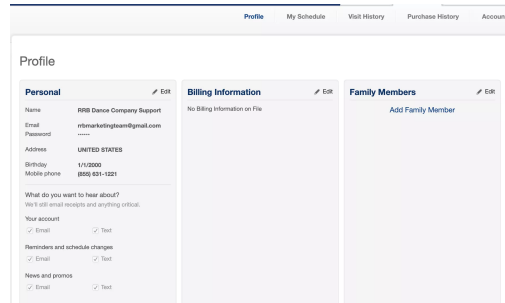

## How do I access my billing?

RRB Dance Company's backend is powered by MindBody. You can access your billing through MindBody Online. All Purchases, Class Bookings, Account Details & Autopay Schedules are available on MindBody Online.

## What platform do I use for online classes?



We host our virtual classes via Zoom Video Communications - [Download Zoom](#). You will receive the link to your virtual class, and unique password to enter the class.

## How do I access practice videos or communicate with teachers?



We use [Band App](#) to facilitate all student, teacher, and parent communication. Students are able to access class videos, important dates, assignments, and communication directly with their class teacher via [Band App](#).

## Make-up classes? Renewal? Holds?

If you were to miss a class due to an excused absence, you will be allowed a make-up in any other class available to the student. The monthly pass is set to auto-renew. If you do not want to continue you just give us a 14-Day notice prior to your renewal, so we have enough time to fill the spot. You are allowed to hold your virtual class pass for a maximum of 2-weeks once per season with a 14-Day notice.

## Purchase Agreement

RRB Dance Company Virtual Membership Plan will start from the first day you attend class to 30 days after that. All payments are made in weekly installments to your membership's Monthly Pass. You will not be able to make any changes midterm. Once signed, your enrollment is confirmed.

All Tuition is accepted via Debit Card and/or Credit Card. No other forms of payments will be accepted. Payments are automatically debited to your account in weekly installments. All purchases are final. No refunds, no exchanges.

Memberships can be put on hold only once for a maximum of 2 weeks in one season. You must give a 14-Day notice to hold your account. Memberships are set to auto-renew. You must give a 14 day notice prior if not renewing your membership.

All Late payments will incur a 10% late penalty fee every week. If a payment is not completed 30 days after tuition is marked late. Then tuition will be marked as delinquent and will be sent to a collection agency.

You will pay for all additional fees involved in pursuing delinquent fees. Including, but not limited to, legal attorney fees, collection agency fees, and/or merchant processor fees.

Credit card chargebacks filed will incur a \$45 merchant processor penalty, and/or any additional legal attorney fees required to dispute the claim. I understand that Membership Plans are not a weekly recurring charge, but installments paid on a monthly pass.

We reserve the right to change or update our studio policies and membership contracts at any given time throughout the year, and we will do so by informing members via written e-mail notice.
